LIMITED WARRANTY

Off Highway Industrial Seating and Accessories

Ultra Seat Corporation expressly warrants from date shipped from Ultra Seat Corporation that the seats and accessories shall be free from defects in material or workmanship as per the following:

- All accessories are covered by a 90 day warranty from date shipped from Ultra Seat Corporation.
 - All non suspension seats in the following series are covered by a 90 day warranty from date shipped from Ultra Seat Corporation. 800, 820, 830, 860, 865, 870, 880
 - All suspension seats in the following series are covered by a 1 year (12 months) or 1000 hour warranty from date shipped from Ultra Seat Corporation. 800, 810, 820, 830, 870, 880
 - All seat covers and foams are covered by a 90 day warranty from date shipped from Ultra Seat Corporation.
 - All OEM specific seats will have a specific warranty based on the series / items.
1. For warranty consideration / claims all seats and accessories must be shipped to Ultra Seat Corporation Edmonton, Alberta, Canada prepaid for inspection with a completed Ultra Seat Corporation warranty claim form unless otherwise agreed to in writing.
 2. The warranty is limited to repairing a defective part or complete replacement of a part.
 3. The repair or replacement of parts under this warranty does not extend the period of this warranty beyond its original expiration date.

The warranty set forth above are the sole and exclusive remedies for breach of this warranty and the purchaser agrees that no other remedy for damages, including without limitations whatsoever, incidental or consequential damages, loss of profile, loss of sales, loss of use of equipment or injury to person or property. The warranty of any seat or accessory will be considered void if in the opinion of Ultra Seat Corporation, one or more of the following conditions are present:

1. The seat or accessory has been altered, modified, changed or reworked in a manner not previously authorized by Ultra Seat Corporation.
2. The seat or accessory has been subjected to abuse, improper use, neglect, accident or use for other than its intended purpose. This includes cuts, burns or lack of maintenance.
3. The seat or accessory is installed in a manner that would subject the seat to abnormal use.
4. Replacement parts have been purchased from another source and have been substituted in such a way as to affect the performance, function or serviceability of the seat or accessory.

Ultra Seat Corporation makes no other express warranty and offers no remedy except as herein described. Ultra Seat Corporation disclaims and liabilities for incidental or consequential damages resulting from breach of any express or implied warranty with respect to the Ultra Seat Corporation product covered by this warranty. All other warranties, expressed. Implied or statutory, including implied warranties of fitness for a particular purpose and of merchantability are limited to the period of this warranty. Failure to give prompt written notice within thirty (30) days of the discovery of any defect in material or workmanship which occurs within the warranty period will void this warranty.
