- Seat covers, back covers, headrest covers, armrests, seat foams, back foams, headrest foams and air lumbar systems are covered by a 90 day warranty from date shipped from Ultra Seat Corporation.
- The standard wheels and gas shocks/covers have a 2 year warranty from date shipped from Ultra Seat Corporation.
- The neoprene single wheels are covered by a 1 year warranty from date shipped from Ultra Seat Corporation.
- Warranty covers parts and in house labor. This warranty does not apply to outside labor, freight, or any other associated costs.

- 3. The seat or accessory is installed in a manner that would subject the seat to abnormal use.
- 4. Replacement parts have been purchased from another source and have been substituted in such a way as to affect the performance, function or serviceability of the seat or accessory.
